SECTION 8. Exposure controls/personal protection**8.1. Control parameters**

During the risk assessment process, it is essential to take into consideration the ACGIH occupational exposure levels for inert particulate not otherwise classified (PNOC respirable fraction: 3 mg/m³; PNOC inhalable fraction: 10 mg/m³).
